### B. Creation of electronic content

1. Writer have already provided ParaDon Books with a print-ready Ms Word files for publication.
2. ParaDon Books Publishing will create ePUB, ePDF and other files compatible with e-readers in the marketplace. All file types are necessary for full distribution of electronic content.

### C. Distribution of electronic content

1. ParaDon Books Publishing will endeavor to distribute your electronic content via all means of online and electronic distribution, including, but not limited to, online or remote access and electronic download via the Internet, cellular networks and wireless networks, and e-retailers (Customer).
2. In connection with each Purchase, ParaDon Books Publishing and their Affiliates may authorize Customers to: (i) access Product via remote electronic access, (ii) download an initial copy of the Product, at or after the time of Purchase, to any device capable of storing or displaying the Product; (iii) download and reinstall additional copies of previously Purchased Product to the same or additional devices; and (iv) utilize search, copy, annotate and paste functionality.
3. We reserve the right to set a Digital List Price (DLP) for the electronic content, and YOU are entitled to a 35% royalty for its creation, or a 50% royalty if the eBook was previously self-published.
4. Payment will be made to Writer at the closing of each month after funds are received.
5. The rating of how well your e-Book and audiobook sells within a six-month period will determine the Advance Payment that will be offer for the Paperback and Hardcover production of your title (by which we will then provide you another publishing contract). We reserve the right to grant a previously self-published author the full 100% commission of his or her AMAZON product(s); given that the specified Kindle eBook was highly reviewed, fully edited, and accepted by us.

6. You agree that any currency-exchange differences, or fees charged by eBook resellers, may be deducted from your royalty payments.

D. Grant us full right

- Indemnification: You are authorizing the product presented by you to ParaDon Books Publishing for sale:
  1. you are the creator of the product that will be copyrighted by us, and has given us the authority to sell and distribute the product;
  2. the product, its sale, or distribution does not infringe any copyright or violate any privacy or other right of any person;
  3. we will promptly notify you in writing if it becomes aware of any breach of the foregoing;
  4. you agree that ParaDon Books Publishing have the right to name (or rename) the manuscript, if we feel it's for the best;
  5. you agree to not to hold ParaDon Books Publishing liable for any lost sales or claims that may arise from our service. You acknowledge that we have obtained all permissions necessary in regards to advertising and selling the title(s) supplied by you. ParaDon Books Publishing has the right to decline or to stop selling any title without cause.
- This agreement shall not be amended or modified except by written agreement executed by ParaDon Books Publishing and the writer.
